



\$5.2 billion in spending for three major programs:


- 1. Transit (\$3.2 billion)

2. Key Financial Issues



FAO Reviewed the Province's 5-Year Transit and Highways Capital Plans

- Transit capital plan totals \$29.2 billion in spending over the next five years
- Highways capital plan totals \$12.9 billion in spending over the next five years



2019 Budget Transit Capital Plan Compared to 2018 Budget Plan

2019 budget transit plan is \$18.5 billion lower over five years compared to 2018 budget transit plan

- On a real per person basis (adjusting for population growth and inflation), growth in transit capital spending to slow over next five years
- However, transit spending expected to be at historically high levels





On a real per person basis (adjusting for population growth and inflation), highways spending will drop from \$201 in 2018-19 to \$139 in 2023-24

Highways capital spending per person, adjusted for inflation (\$)





Estimating Highways Investment Required to Maintain Service Levels

- The FAO estimated highway spending needed to maintain current service levels (i.e., spending required to meet cost drivers of driving-age population growth and inflation)
- Results: 5-year highways spending plan exceeds investment required to maintain status quo service levels
